Welcome to our community from the Ewing Police Department, Community Relations Unit (CRU). This unit is comprised of the following detectives, Detective Paul Digristina, Detective Danielle Bethea, Officer Jeremie McCall along, with our supervisor Detective Sergeant Michael Flynn. Some of our duties and responsibilities include addressing quality of life complaints, ensuring rental properties are maintained, along with being a direct liaison to TCNJ and Rider University administrations.

Please take time to read and review this packet to have a better understanding of subjects such as: garbage and recycling pickup, Ewing Township Ordinances, New Jersey State Traffic Violations and New Jersey State Criminal Statutes. We have prepared this packet to assist all students living off campus with as much information as possible with the intent to keep our neighborhoods safe and clean.

The Ewing Police Department strives to be transparent and will enforce ALL state law and local ordinances, which encompass but not limited to underage drinking or possession of alcohol, noise, theft of street signs, improper parking and disorderly behavior. These offenses could carry a fine ranging from \$250.00 to \$2,000.00 and may also include community service, counseling, and disciplinary action from the associated school. If a police encounter takes place, always be truthful, respectful and forthcoming with information that may be requested by the officer. Also, we suggest tenants to introduce themselves to their neighbors and possibly exact phone numbers in case they are needed in the future. This is beneficial if there is a parking or noise concern when having a social gathering. If a tenant is going to have a large gathering of associates at the property it may be advantageous to contact your neighbor to inform them of the gathering. As a reminder, most Ewing residents have lived here for many years, and while then do not mind the college atmosphere, please be courteous to their properties and the cleanliness surrounding the property.

The police department works in conjunction with Ewing Code Enforcement, which is responsible for matters relating to building and fire codes, along with property maintenance. As a tenant, you should have direct contact with your landlord or property management company to address any health or safety concerns within or on the property to ensure all regulations are following state and local codes. As a tenant, if a landlord or management company is not complying or responding to your concerns, or you have questions about codes, contact Ewing Code Enforcement at (609) 538-7611. The police department and code enforcement work closely together and will assist tenants to resolve matters relating to safety and building codes with their landlord. If there are any questions or concerns you may have, please contact a member of the Community Response Unit at the below listed phone number or email. Again, we want to welcome you to the Township of Ewing and hope your time here is enjoyable and safe.

Welcome to Ewing Park. This letter is from your neighbors who are members of the Ewing Park/Brae Burn Association.

The mission of this CIVIL Association is to be proactive in keeping the quality and values of our homes, as well as provide a medium for the exchange of ideas and concepts that promotes harmony, safety, and a wholesome neighborhood.

We are hoping you will take pride in helping us maintain the neighborhood, and respect it as you would your PARENT'S neighborhood. We take pride in our homes. Below is a list of items, suggestions, and recommendations to assist you:

- Recycling is collected *every other Tuesday*. There is a list provided on the dates for 2013 and *what to recycle and what not to recycle*. You may obtain recycle cans from the Public Works Department, 136 Scotch Road, Ewing, NJ. We request that you keep them in the rear or side of your home. Any questions, please call (609) 832-3382.
- Please observe the 2 hour parking signs. The residents of the street abide by rules and ordinances set forth by the Township of Ewing.
- Streets will be monitored by the association and police will be notified.
- We park in our driveways to keep our street looking like an attractive community rather than a mall parking lot.
- As rentals, you are instructed to ALWAYS park in your driveway due to the large number of cars at the residence. This leaves the street clear for visitors and guests of residents.
- We park correctly according to the flow of traffic; this will ensure that you or your guests are not ticketed by township police.
- We park in front of our property when we park on the street and encourage our visitors to park in front of the home they are visiting, and not in front of a neighbor's property or home.
- Streets are monitored by this association along with the cooperation of the Ewing Police Department due to the close proximity of the College of New Jersey. This will keep streets from getting congested with bumper to bumper parking.
- Be aware of NOISE ordinances in Ewing; we monitor noise past the hour of 10:00 pm NOISE includes loud talking, loud music, slamming of car doors, ball bouncing and/or any extra loud noise that is a nuisance.
- If you are going to have meetings and/or parties, please inform your guests of the ordinances accordingly and arrange parking in advance. Parties are generally held at rental halls for guests numbering more than 15. Your college campus has overflow parking on Green Lane. We hope you will take all suggestions rendered.
- The College of New Jersey Task Force has indicated to this association that students have been given rules for behavior when living off campus and can be disciplined for violating the college's code of conduct and for breaking township laws. Your campus security monitors this area along with the Ewing Police Department. We would like you to be aware of our concerns and expect your cooperation.
- Rider University will be notified if residents are Rider students.

We wish you the best in your future endeavors as you strive to acquire your career goals.

A Community Notification System gives those in charge a chance to reach out to the public to inform them of community and emergency events. This system, combined with our other alert methods, is designed to get messages to you the public, quickly and effectively. Some examples of community notification are: road closures, storm related news, concerts and meetings. This does not preclude you from calling 911 if you need emergency information; it provides an opportunity for us to disseminate critical information to you, if and when you choose. The reason for the form is to gather as many means of contact as you may have, so that in the event that a notification is necessary in Ewing Township we can notify you in multiple ways.

- We maintain a constantly updating database of all land line telephone numbers registered in Ewing. Feel free to list any additional land line phone numbers, however we are most interested in gathering cell phone numbers and email addresses.
- If you have a Ewing address, please provide it in the Street Address field, in the event of a localized emergency your local address will integrate with the notification systems mapping capabilities.
- This information will remain in the custody of Ewing Township at all times, and will only be used for Notification purposes.

# Recycling

Curbside recycling in Ewing Township is handled by the Mercer County Improvement Authority, located at [www.mcia-nj.com](http://www.mcia-nj.com). Most questions regarding curbside recyclables can be answered by visiting their site. MCIA maintains a quality [FAQ](#) as well as a [list of items](#) that can and cannot be recycled at the curb.

Ewing Township also offers some of its own recycling programs, including residential brush drop-off and electronics recycling. Brush can be dropped off at the lot on Jack Stephen Way, off of Parkway Avenue and adjacent to the Naval Jet Propulsion Center. Electronics can no longer be placed out for curbside garbage pick up, but can be dropped off for recycling at the Department of Public Works, located at 136 Scotch Road. ## What Do I Do With ...?

The following is an item by item list of some of the items we most often receive questions about. Not sure what to do with it? Check here!

- **Batteries**  
Alkaline batteries, (dry cell) , AAA, AA, A, C, D & 9 volt are to be placed in the garbage with your regular household refuse.
- **Car & Boat (wet cell) batteries**  
Check with local repair facilities to see if they accept or turn it in when you get a new battery. Otherwise, take to Mercer County Household Chemical Waste Disposal Day.
- **Rechargeable batteries (watch, cell phone)**  
Batteries less than 2 lbs. can be disposed of at locations such as Ewing Recreation Building, Radio Shack, Lowe's Home Depot, Sears. Look for the drop off container.
- **Bubble Wrap**  
Dispose with your regular household refuse or call a local shipping outlet to see if they will accept. **DO NOT RECYCLE.**
- **Cell Phones**  
A drop off container is located in the Township lobby or the Ewing Recreation Building. All related equipment is accepted including batteries and chargers.
- **Computers**  
Recycle them at Ewing Recreation Building located at 136 Scotch Rd or one of the Mercer County Electronics Waste Days
- **Electronics**  
Residents may drop them off at 136 Scotch Rd or wait to dispose of them thru the Mercer County Household Chemical Waste Disposal Day or the Electronic Disposal Day.
- **Fluorescent Bulbs**  
Dispose thru the Mercer County Household Chemical Waste Disposal Day.
- **Insecticides, Insect Repellents**  
Mercer County Household Chemical Waste Disposal Day.
- **Latex Paint**  
Latex paint is to be placed in the garbage with your regular household refuse. Remove lids, air dry the cans or fill with sand or kitty litter prior to placing out for garbage collection. **DO NOT RECYCLE.**
- **Paint**  
Enamel or oil based paint, paint thinners and turpentine, are to be taken to the Mercer County Household Chemical Waste Disposal Day.
- **Pesticides**  
Mercer County Household Chemical Waste Disposal Day.
- **Pizza Boxes**  
Dispose with your regular household refuse. **DO NOT RECYCLE.**
- **Plastic Flower Pots and Flower Flats**  
Return to the place of purchase or place with your regular household refuse. **DO NOT RECYCLE.**
- **Pool Chemicals**  
Mercer County Household Chemical Waste Disposal Day.
- **Scrap Metal**  
Refer to the Yellow Pages for local scrap metal yards or you may drop it off at our Residential Convenience Center located at 136 Scotch Rd

- **Take Out Containers**

Plastic, Styrofoam, cardboard (pizza boxes included) are to be disposed thru your regular household refuse. **DO NOT RECYCLE.**

- **Televisions**

Residents may drop them off at 136 Scotch rd or dispose of them thru the Mercer County Household Chemical Waste Disposal Day or the Electronic Disposal Day.

- **Tires**

For a \$2.00/tire charge, tires off the rim can be taken to the Ewing Recreation Maintenance Building, located at 136 Scotch Rd (please call for appointment) 609-883-2902

- **Used Motor Oil**

Used motor oil can also be taken to the Mercer County Household Chemical Waste Disposal Day

- **VCRs**

Dispose thru the Mercer County Household Chemical Waste Disposal Day or the Electronic Disposal Day. Residents may also drop them off at 136 Scotch Rd







# ANIMAL HOUSE



- If in any twenty-four-month (24) period, the police are detailed to the rental property on separate occasions, of conduct upon or in proximity to any rental premises, and attributable to the acts or incitements of any of the tenants of those premises, have been substantiated by prosecution and conviction in violation of any provision of Title 2C of the New Jersey Statutes or the Ewing ordinance governing disorderly conduct (284-12), the municipal governing body or any officer or employee of the municipality designated by the governing body for the purpose may institute proceedings to require the landlord of those premises to post a bond.
- The landlord will be required to post up to a **\$5,000.00** bond for future POLICE SERVICES and to pay any fines imposed against the location.
- A landlord may recover from any tenant any amount of security actually forfeited from the bond

BEVERAGES, OF THE CODE OF THE TOWNSHIP OF EWING

The Township Council of the Township of Ewing hereby Ordains:

SECTION 1. Chapter 91, *ALCOHOLIC BEVERAGES*, of the Code of the Township of Ewing, be and the same is hereby amended and supplemented, to add the following new section:

91-17 Underage Persons, Possession or Consumption of Alcoholic Beverages on Private Property.

91-17 Possession or Consumption of Alcoholic Beverages by Underage Persons on Private Property.

It shall be unlawful for any person under the legal age who, without legal authority, knowingly possesses or knowingly consumes an alcoholic beverage on private property.

91-18 Exceptions:

- a. It shall not be illegal for such under-aged person to consume or possess an alcoholic beverage in connection with a religious observance, ceremony, or rite; or consume or possess an alcoholic beverage in the presence of and with the permission of a parent, guardian or relative who has attained the legal age to purchase and consume alcoholic beverages.
- b. It shall not be illegal for such under-aged person to consume or possess an alcoholic beverages while actually engaged in the performance of employment by a person who is licensed under Title 33 of the revised Statutes of the State of New Jersey; or, while actually engaged in the preparation of food while enrolled in a culinary arts or hotel management program at a county vocational school or post secondary educational institution; except that this Ordinance shall not be construed to preclude the imposition of a penalty under N. J. S. A. 33: 1-31, et. Seq., as amended from time to time, or any other law, against a person who is convicted of unlawful alcoholic beverage activity on or at premises licensed for the sale of alcoholic beverages.

## **224 Littering**

### **224-1 Prohibited acts:**

It shall be unlawful for any person or entity to place upon, deliver, deposit, drop upon, ~~throw upon~~, leave or abandon within or upon any public or private property any garbage, cans, bottles, cartons and any other type of refuse whatsoever, or any handbills, advertisements, brochures, flyers, shoppers, samples or other unsolicited commercial matter, printed or otherwise, of every kind or nature whatsoever.






## Section 408 Nuisances, Noise

Amplifiers



It shall be unlawful for any person to make, continue or use to be made or continued any loud, unnecessary or unusual noise or any noise which either annoys, disturbs, injures or endangers the comfort, repose, health, peace or safety of others within the limits of the Township. Such noise is prohibited between the hours of 10:00 p.m. and 7:00 a.m., on Sunday, Monday, Tuesday, Wednesday and Thursday; and the hours of 11:00 p.m. and 7:00 a.m. on the days of Friday and Saturday, in a manner as to be plainly audible at a distance of 50 feet from the building, structure or vehicle in which noise is emanating shall be prima facie evidence of a violation of this section.

ORDINANCES

AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EWING IN THE COUNTY OF MERCER PROHIBITING PUBLIC URINATION.

257-11      Urinating in public, prohibited

No person shall urinate or place any bodily waste of humans on any public street, sidewalk or other place in public view, or to which the public is invited or has access except in a lavatory toilet or similar facility.

257-3      Graffiti

To cover, mark, write on, paint, color or otherwise mark, disfigure, or draw on any private or public property anything of any nature whatsoever without the express consent of the owner.

124-1      Open Burning

No person shall burn or permit to be burned papers or other matter on any public street or any other open area, public or private, located within the Township, except in an approved fire container.

Upon conviction thereof, punishable by a fine not exceeding \$2,000 or by imprisonment for a term not exceeding 90 days or by a period of community service not exceeding 90 days, or such fine, imprisonment and/or community service, in the discretion of the Municipal Court Judge.

## **39:4-135 Improper Parking**

### **Parking; direction and side of street; angle parking; one-way street**

The operator of a vehicle shall not stop, stand or park the vehicle in a roadway other than  
headed in the  
road and with the curb side of the vehicle within  
the edge of the roadway, except as follows:

1. Upon those streets which have been designated by ordinance and have been marked or signed for angle parking, vehicles shall be parked at the angle to the curb designated and indicated by the ordinance and marks or signs.

b. Upon one-way streets, local authorities may permit parking of vehicles parallel with the left-hand edge of the roadway headed in the direction of traffic, on the left-hand side of the road and with the curb side of the vehicle within six inches of the edge of the roadway.

39:4-135. Parking; direction and side of street; angle parking; one-way street

The operator of a vehicle shall not stop, stand or park the vehicle in a roadway other than parallel with the edge of the roadway headed in the direction of traffic, on the right-hand side of the road and with the curb side of the vehicle within six inches of the edge of the roadway, except as follows:

- a. Upon those streets which have been designated by ordinance and have been marked or signed for angle parking, vehicles shall be parked at the angle to the curb designated and indicated by the ordinance and marks or signs.
- b. Upon one-way streets, local authorities may permit parking of vehicles parallel with the left-hand edge of the roadway headed in the direction of traffic, on the left-hand side of the road and with the curb side of the vehicle within six inches of the edge of the roadway.

39:4-136. Parking on highway; removing vehicle; disabled vehicle

No person shall park or leave standing a vehicle, whether attended or unattended, upon the roadway, outside of a business or residence district, when it is practicable to park or leave it standing off the roadway. In no event shall a person park or leave standing a vehicle whether attended or unattended, upon a roadway, unless a clear and unobstructed width of not less than fifteen feet upon the roadway opposite the standing vehicle is left for free passage of other vehicles thereon, nor unless a clear view of the vehicle may be obtained from a distance of two hundred feet in each direction upon the roadway.

In the event that a vehicle is disabled or otherwise unable to proceed while on the roadway of a highway, the driver or person in charge of such vehicle shall immediately, by the quickest means of communication, notify the nearest police authority. Any vehicle, upon a roadway, which is disabled to the extent that the operator cannot move it, or any unoccupied vehicle parked or standing in violation of this chapter shall be deemed a nuisance and a menace to the safe and proper regulation of traffic and any peace officer may provide for the removal of such vehicle. The owner shall pay the reasonable costs of the removal and storage which may result from such removal, before regaining possession of the vehicle.

39:4-138 - Places where parking prohibited; exceptions; moving vehicle not under one's control into prohibited area.

Except when necessary to avoid conflict with other traffic or in compliance with the directions of a traffic or police officer or traffic sign or signal, no operator of a vehicle shall stand or park the vehicle in any of the following places:

- Within an intersection;
  - On a crosswalk;
  - Between a safety zone and the adjacent curb or within at least 20 feet of a point on the curb immediately opposite the end of a safety zone;
  - In front of a public or private driveway;
  - Within 25 feet of the nearest crosswalk or side line of a street or intersecting highway, except at alleys;
  - On a sidewalk;
  - In any appropriately marked "No Parking" space established pursuant to the duly promulgated regulations of the Commissioner of Transportation;
  - Within 50 feet of a "stop" sign;
  - Within 10 feet of a fire hydrant;
  - Within 50 feet of the nearest rail of a railroad crossing;
  - Within 20 feet of the driveway entrance to any fire station and on the side of a street opposite the entrance to any fire station within 75 feet of said entrance, when properly signposted;
  - Alongside or opposite any street excavation or obstruction when stopping, standing, or parking would obstruct traffic, when properly signposted;
  - On the roadway side of any vehicle stopped or parked at the edge or curb of a street;
  - Upon any bridge or other elevated structure upon a highway, or within a highway tunnel or underpass, or on the immediate approaches thereto except where space for parking is provided;
  - In any space on public or private property appropriately marked for vehicles for the physically handicapped pursuant to P.L.1977, c.203 (C.39:4-197.5), P.L.1975, c.217 (C.52:27b)-119 et seq.) or any other applicable law unless the vehicle is authorized by law to be parked therein and a handicapped person is either the driver or a passenger in that vehicle. State, county or municipal law enforcement officers or parking enforcement authority officers shall enforce the parking restrictions on spaces appropriately marked for vehicles for the physically handicapped on both public and private property.
- No person shall move a vehicle not lawfully under his control into any such prohibited area or away from a curb such distance as is unlawful.

39:4-138.3. Parking in front of driveway permitted; conditions

1. Notwithstanding the provisions of R.S.39:4-138 to the contrary, any municipality may, by ordinance, permit the parking of motor vehicles in front of private driveways whenever both the motor vehicle and driveway involved are owned by the same person, whenever the motor vehicle is owned by a member of the same household as the owner of the private driveway, or whenever the owner of the private driveway authorizes the parking of a motor vehicle in front of the private driveway; and where such parking is not otherwise prohibited and the parking thereof would not interfere with the normal flow of traffic.

**ORDINANCE NO. 17-18**

**AN ORDINANCE AMENDING THE REVISED GENERAL ORDINANCES OF THE TOWNSHIP OF EWING IN THE COUNTY OF MERCER, TO ADD § 225-10.6, TO PROHIBIT PARKING IN FRONT OF A PUBLIC OR PRIVATE DRIVEWAY**

**WHEREAS**, pursuant to N.J.S.A. 39:4-138(d), it is unlawful for an operator of a vehicle to stand or park a vehicle in front of a public or private driveway.

**WHEREAS**, the Township wishes to add a provision to its parking ordinance to prohibit parking in front of a public or private driveway.

**BE IT ORDAINED** by the Council of the Township of Ewing, County of Mercer that the Code of the Township of Ewing be amended as follows:

Section 1 Chapter 225, TRAFFIC REGULATIONS, Section 10.6, PARKING PROHIBITED IN FRONT OF A PUBLIC OR PRIVATE DRIVEWAY, is hereby added to read as follows:

**§ 225-10.6 PARKING PROHIBITED IN FRONT OF A PUBLIC OR PRIVATE DRIVEWAY.**

No person shall park or stop a motor vehicle at any time in front of a public or private driveway or within five feet of the opening of a public or private driveway.

Section 2 Severability. Should any section, clause, sentence, phrase or provision of this article be declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this article.

Section 3 Repealer. All prior ordinances or parts of same inconsistent with any provisions of this article are hereby repealed to the extent of such inconsistency.

Section 4 Effective Date. This ordinance shall take effect upon final adoption and publication in accordance with law.

## Posting of Occupancy Load

The Ewing Township Fire Prevention Office requires all rental property owners, to register their properties on an annual basis under the Division of Fire.

Every rental property in Ewing has an Occupancy Load Sign posted in their properties. It clearly states how many tenants are allowed to occupy and how many people are allowed in the property at one time.

You as a tenant are required to adhere to the required amount of people allowed in your property. Failure to do so will result in fines being issued to all tenants that reside in the property.
